For purchased material based on the currently agreed Incoterms and the associated freight responsibility on the part of ASMPT, we ask you to observe the following information and shipping instructions.

Documents accompanying the goods:

The ASMPT PO number as well as the complete shipment details for dispatch must be stated on all documents accompanying the goods.

- Delivery note; Packing list; Proforma invoice (Customs invoice); Export declaration
(*Number of packages, Weights, Dimensions; Content; ASMPT PO#; etc.*)

Special service and courier:

Special and express deliveries are only to be released by ASMPT. Scheduling for collection and delivery takes place via ASMPT and supplier.

Please note:

- The supplier must ensure that the packaging is neat and suitable for the mode of transport.
- All packages must be properly labeled for clear identification.
- Any information and declaration about the insurance coverage at transport is not relevant.
- If the supplier is responsible for transport costs, e.g. in the event of a warranty claim, the latter is obliged to commission his service provider and deliver to ASMPT on time. The requirements and information on documents accompanying the goods remain unchanged.
- In the case of deliveries which contain dangerous goods, the supplier is obliged to provide the freight forwarder with the dangerous goods data required by law when placing the order. The supplier is also responsible for the legally compliant packaging, labeling and documentation for the respective mode of transport.
